To ensure the performance of Phipun Subdistrict Administrative Organization In accordance with the regulations of the Office of the Prime Minister regarding Giving or receiving gifts by government officials, ๒๐๐๓, in accordance with the Organic Law on Prevention and Suppression of Corruption, regarding receiving property or other benefits of government officials according to Section ๓๐๓, core values and organizational culture of Phipun Subdistrict Administrative Organization Including in line with indicator ๓๐, prevention of corruption. Sub-indicator ๓๐.๐: Actions to prevent corruption, No Gift Policy, Section 0๒๕, Declaration of No Gift Policy intent, performance of duties. and is committed to the principles of performing duties with honesty, transparency, accountability, and good governance in administration The President of Phipun Subdistrict Administrative Organization hereby issues the following announcement

Article ๑: Administrators, Subdistrict Administrative Organization Council members, Subdistrict Administrative Organization employees, hired employees, teachers, and educational personnel. Refrain from receiving gifts or presents from individuals. or subdistrict administrative organization

Article ๒ Giving gifts to outside persons or agencies Can be given according to customs, traditions, culture or etiquette practiced in society. Can be done without violating relevant laws.

Point ๓: Refrain from receiving gifts. or any other benefits in any case Except in unavoidable cases, comply with relevant laws and regulations.

Point ๔: Promote blessings with greeting cards. or use electronic media instead of giving gifts

Item ๔ informs the policy of refraining from receiving and giving gifts. to stakeholders Be informed through various channels for everyone to know.
